

## Terms and conditions

Campaign Title: Kenanga Investors Move It Move It Challenge

Campaign Period: 8 January – 3 March 2024

## 1. The Challenge

- 1.1. The Kenanga Investors' Move It Move It Challenge 2023 ("the Challenge") is organised by Kenanga Investors Berhad ("KIB") and promoted on its holding company, Kenanga Investment Bank Berhad's ("KIBB") social media profiles.
- 1.2. The Challenge is scheduled to commence on 8 January 2024, 12:00 A.M. and will conclude on 3 March 2024, at 11:59 P.M. ("Challenge Period").
- 1.3. Participation in this the Challenge shall be deemed as an acceptance of the Terms and Conditions ("T&C") stated herein, as well as consent to the use of the Participant's personal information in accordance with our Privacy Notice, which can be found on KIB' website at <u>https://www.kenangainvestors.com.my/privacy- policy</u>. Non-compliance with or a breach of any of these T&C may result in the disqualification of the Participant at any stage of the Challenge, and prizes won may be forfeited, withheld, withdrawn, or reclaimed.

# 2. Eligibility

- 2.1. The Challenge welcomes participation from all Malaysians, including both new and current KIB clients and advisers (hereinafter referred to as the "Eligible Participants"), with the exception of:
  - a) Individuals under 18 years old;
  - b) Permanent and/or contract employees of KIB and Kenanga Group of Companies;and
  - c) Individuals directly engaged with the Challenge, such as the social media agency and affiliated vendors.
- 2.2. To participate in this Challenge, the Eligible Participants are required to set their account settings to 'Public' on their following social media accounts:

- 2.4. The Eligible Participants must complete a minimum of 30 minutes of workout in any form, including but not limited to activities such as cardio, strength training and yoga.
- 2.5. The Eligible Participants are required to record and share their workout sessions by posting photos, videos, or screenshots that capture the data of the workout session by their tracking devices on any of the following social media platforms:
  - a) Facebook
  - b) Instagram
  - c) TikTok



- 2.6. Please ensure that the workout sessions shared on social media include essential data such as the duration, date and time of the workout.
- 2.7. The Eligible Participants must include the following hashtags to each of their posts related to The Challenge: #KIBmoveitmoveit #investinyou #KenangaInvestors
- 2.8. The Eligible Participants' posts must remain accessible and publicly viewable on their respective social media profiles for the entire duration of the Challenge and prize fulfilment period.
- 2.9. The Eligible Participants must submit original content only and should not repost or previously posted/shared content by others and/or another individual's content.
- 2.10. The Eligible Participants must adhere to the requirements of the Challenge Mechanics within item 4.

## 3. Personal Data

- 3.1. The Eligible Participants affirms the accuracy of all information provided at the time of the Challenge entry. Misrepresentation of any facts or personal particulars (deemed material by KIB) shall result in disqualification and/or the forfeiture, withholding, withdrawal, or reclaiming of any prizes won.
- 3.2. By participating in this Challenge, the Eligible Participants agree to allow KIB to use, promote, and publish their identity for advertising and publicity purposes without additional compensations or prior notice.
- 3.3. For this Challenge, the Eligible Participants agree to allow KIB to contact them using the personal contact information that has been provided, the information of which will be stored until the Challenge has concluded.
- 3.4. Where the Eligible Participants provides KIB with personal data of individual third parties, the Eligible Participants has obtained their requisite consent:
  - a) For their Personal Data to be provided to KIB as KIB may require for the purpose of processing related documents and matters pursuant and in connection to this Terms and Conditions;
  - b) For KIB to disclose the said Personal Data to other members of Kenanga group of companies; and/or
  - c) For KIB to disclose the said Personal Data so as to comply with any law or regulatory requirements.

#### 4. Mechanism and Rules

4.1. The Challenge comprises of three (3) Categories:

#### 4.1.1. Weekly Challenge:

- Weekly winners will be determined based on the speed of completion and their adherence to the Challenge criteria.
- The first three (3) participants to complete the 30-minute workout within the designated week will be deemed as the weekly winners.
- The names of the weekly winners will be announced within five (5) Business Days (hereinafter defined) from the end of each week's challenge.



## 4.1.2. Monthly Challenge:

- Monthly winners will be determined based on the highest number of eligible workout posts within a single month and adherence to the Challenge criteria.
- The top three (3) participants with the highest number of workout posts within the month will be deemed as the monthly winners.
- The names of the monthly winners will be announced within five (5) Business Days from the end of each month's challenge.

## 4.1.3. Grand Prize Challenge:

- The grand prize winners will be the top two (2) participants with the highest number of workout posts throughout the Challenge, with each participant having met the minimum requirement of four (4) posts per month.
- The grand prize winners will be announced within fourteen (14) Business Days from the last day of the two-month challenge.

• Scenarios:

\*In the given scenario, Participant B and C emerge as the Grand Prize winners due to consistently meeting the minimum workout post requirement of four (4) for every month and accumulating the highest number of workout posts compared to other participants.

- If multiple participants qualify for the grand prize and meet all the requirements, we will consider the time of posting as a deciding factor in determining the first individual to post the Challenge.
- Therefore, the winners of the Grand Prize will be the first two (2) participants to successfully complete the Challenge and post their entries.

- 5.1.
